

Consent to Receive Newsletters and Promotional Materials

A legally capable individual (hereinafter, the “User”), in pursuance of the requirements of Federal Law of 13 March 2006 No. 38-FZ On Advertising (hereinafter, the “Federal Law on Advertising”), gives his/her consent to Joint Stock Company Information Agency RUTRANS (hereinafter, the “Organizer”) to receive newsletters and promotional materials (hereinafter, the “Consent”).

1. The Consent is recognized as the written consent of the User to receive newsletters and promotional materials given in accordance with part 1 of Article 18 of the Federal Law on Advertising.
2. The Consent is given by the User on a website accessible online at www.bizavsafety.aero (hereinafter, the “Site”).
3. Activation of the check-box next to the text “I agree to receive newsletters and promotional materials” and clicking the “Provide an order” or “Register” button constitutes acceptance of this Consent.
4. Consent is given for the Organizer to perform the following actions through telecommunication networks:
 - 4.1. Distribution through the mobile communications network of short informational and/or promotional text messages (SMS messages), including transmission of such text messages (SMS messages) with the use of numeration that does not correspond to the Russian numbering system and plan, to the User’s mobile phone number indicated by the User upon registration on the Site;
 - 4.2. Mailing of informational and/or promotional messages to the User’s e-mail address indicated by the User upon registration on the Site.
5. Actions specified in clause 4 hereof are performed for the purposes, including, but not limited to, communication to the User of information, including of an advertising nature, about activities of the Organizer and its partners, about special offers, promotional actions, bonus and other programs of the Organizer and its partners, about events and presentations of the Organizer and/or its partners.
6. The Consent is given for an indefinite term until withdrawn.
7. The User may withdraw his/her Consent by sending a written withdrawal of the Consent to the Organizer’s e-mail address: rutrans.info@gmail.com.
8. From the moment of receipt of the withdrawal in accordance with clause 7 hereof the Organizer shall cease using the User’s telephone number for distribution of informational and promotional messages.
9. These terms and conditions may be amended and/or supplemented by the Organizer unilaterally without any special notice. The current version of the Consent is a public document available at www.bizavsafety.aero.
