

Consent to Personal Data Processing

1. Hereby the User, acting of his/her own free will and volition and on his/her own behalf, as well as confirming his/her legal capability, gives this consent to processing of personal data (hereinafter, the “Consent”) to Joint Stock Company Information Agency RUTRANS (hereinafter, the “Operator”).
2. The Consent is given by the User on a website accessible online at www.bizavsafety.aero (hereinafter, the “Site”).
3. Clicking the “Register” button under the text “I hereby accept the terms and conditions of the Offer Agreement and give my consent to processing of Personal Data” constitutes acceptance of this Consent;
4. The User agrees to processing of his/her Personal Data both with and without the use of automation facilities.
5. The Consent is given to processing of the following Personal Data:
 - 5.1. Personal Data entered by the User in electronic form upon registration on the Site:
 - Surname, name, patronymic;
 - PLACE of employment (name of the organization) and position;
 - e-mail address;
 - mobile telephone number.
 - 5.2. Personal Data entered by the User when placing an order on the Site:
 - bank card details (bank card number, name and surname of the bank card holder, CVC/CVV code, bank card validity period).
 - 5.3. Personal Data collected when using the Site:
 - User’s device identifier;
 - time and date of using the Site;
 - information on the operating system version and model of the User’s device.
6. Processing of Personal Data is performed for the purpose of:
 - conclusion of the Offer Agreement between the Operator and the User;
 - ensuring of the possibility of making settlements between the Operator and the User on the basis of the Offer Agreement;
 - mailing out of promotional and informational materials;
 - ensuring of the possibility of communication between the Operator and the User in the course of performance of contractual obligations on the basis of the Offer Agreement;
 - conducting of statistical and other research based on the User’s depersonalized personal data;
 - analysis of possible errors in the operation of the Site and improvement of its operation.
7. The User gives his/her consent to the following actions with Personal Data:
 - collection;
 - recording;
 - systematization;

- accumulation;
- storage;
- clarification (updating, change);
- retrieval;
- use;
- transmission (distribution, provision, access), including cross-border transmission;
- depersonalization;
- blocking;
- deletion;
- destruction;
- transfer to the third parties for the purposes specified in clause 5 hereof.

8. This Consent is given for an indefinite term until withdrawn.

9. The User may withdraw his/her Consent by means of an appropriate written document, which can be sent in simple written form to the Operator's address specified in clause 11 hereof, as well as to the Operator's email address: rutrans.info@gmail.com.

If the User withdraws his/her Consent to Personal Data processing, the Operator may continue processing of Personal Data without the User's consent on the grounds specified in clauses 2-11 of part 1 of Article 6, part 2 of Article 10 and part 2 of Article 11 of Federal Law No. 152-FZ On Personal Data of 27 July 2006.
